The Certificate IV in Disability Support prepares individuals for a career as a disability support worker, providing them with the knowledge, skills and attitudes necessary to effectively support people with disabilities in various community settings. The course covers person-centered practices, advocacy, support strategies, and occupational health and safety principles, empowering learners to assist individuals with disabilities in achieving independence, choice, and control over their lives.

## Course Entry Requirements

Competency is assessed through a combination of practical application and demonstration of skills, research, analysis and completion of competency based workbooks.

## Work Placement

If you're not currently working in the sector, no problem — we can help you organise a suitable placement (minimum 30 hours recommended). A placement coordination fee will apply.

**Two units must be assessed in the workplace. You can:**

- Complete these in your own workplace (if suitable)
- Arrange your own facility, subject to a site inspection and approval by AHT
- Or ask us to organise a placement for you through our industry partners, helping you gain real-world experience and career connections. (additional cost applies)

## Practical Experience and Assessment

Students get the opportunity to undertake practical skill development throughout the course in the All Health Training simulated environment with trainers who are experts in their field and maintain currency in the industry. Students are also assessed based on skill development throughout the course.

## Credit Transfers (CT) + Recognition of Prior Learning (RPL)

If students have already successfully completed unit/s of competency which are included within the current listing qualification AHT offers, credit transfers may be granted. Competencies gained through other formal study or experience may be acknowledged through a Recognition of Prior Learning Process.

## Further Education

For career advancement, consider pursuing higher-level qualifications like Diploma of Community Services or Advanced Diploma of Community Sector Management. These qualifications can open doors within the healthcare sector.
