Statement of Fees

Fees for 2026

From 2026, the **Victorian State Government, through the Department of Jobs, Skills, Industry and Regions (DJSIR)**, has significantly reduced training funding for many private Registered Training Organisations. As a result, **government-funded places are not available** at All Health Training, and enrolments are offered on a **fee-for-service basis**.

All Health Training remains committed to delivering high-quality, industry-aligned healthcare training and continues to invest in face-to-face delivery, practical learning environments, and experienced trainers.
